 2. your vehicle description and registration number of your nominated vehicle; and
 3. your billing account or payment card details.
3. Purpose for collection.
 - a. The purposes of BML collecting your personal information is to:
 1. to assess your application for Buyer access to the Brisbane Markets, which will include but will not be limited to verifying your identification by way of you producing photographic ID (for example, driver's licence, if BML consents to you having vehicle access); and
 2. if successful, to provide you with Buyer vehicle access in accordance with the times and days permitted in your Buyer access category to the Brisbane Markets® (such access may be restricted to, or limited by, the days and hours of operation at the Brisbane Markets® that BML determines from time to time);
 3. provide you with relevant information regarding your access to and use of BML's premises, such as repairs or maintenance works; and
 4. ensure your ongoing compliance with car parking conditions and, if necessary, conducting enforcement activities to protect BML's rights,
 - b. once provided with a Buyer access, to:
 1. include you in BML's access database;
 2. provide you with medical treatment and to respond to, and administer, any medical treatment in the event of any emergency which may occur on BML's premises;
