Brisbane Markets Limited ACN 064 983 017 and its Related Bodies Corporate (as defined by s 9 of the *Corporations Act 2001* (Cth)) (BML) are committed to protecting the privacy of individuals and their personal information and (which may include sensitive information) complies with the *Privacy Act 1988* (Cth) (Privacy Act).

Please read this carefully as it will have important consequences for you in relation to the collection, use and disclosure of your personal information you provide to BML.

You understand that:

1. BML is the party who is collecting your personal information and can be contacted at privacyofficer@brisbanemarkets.com.au or alternatively you can write to us at PO Box 80, Brisbane Markets Qld 4106 or on (07) 3915 4200.
2. BML will collect your personal information directly from you and (if applicable) your employer or the company who has contracted you or your employer to perform services.
3. The purpose of BML collecting your personal information is to:
 - a. assess your application for access to the Brisbane Markets, which will include but will not be limited to verifying your identification by way of you producing photographic ID (for example, driver's licence, if BML consents to you having vehicle access);
 - b. if relevant, confirm your employment with your employer;
 - c. if your application is successful, provide you with access to Brisbane Markets, which may include access-controlled premises, by issuing you with the appropriate passes, cards, permits or registrations, in accordance with any conditions of your entry (such access may be restricted to, or limited by, the days and hours of operation at the Brisbane Markets that BML determines from time to time);
 - d. provide you with relevant information regarding your access to and use of the Brisbane Markets, such as provision of services or other events occurring at this site;
 - e. record and monitor your access in and out of the Brisbane Markets premises for security purposes;
 - f. ensure your ongoing compliance with BML's car parking conditions and, if necessary, conducting parking enforcement activities to protect BML's rights;
 - g. include you in BML's access database;
 - h. provide you with medical treatment and to respond to, and administer, any medical treatment in the event of any emergency which may occur on BML's premises; and
 - i. provide you with correspondence relating to the Brisbane Markets and the Policies, Procedures, regulations and parking conditions that apply to the Brisbane Markets, direct marketing associated with the Brisbane Markets and your requirements for ongoing access to the Brisbane Markets, and you acknowledge and agree to your personal information being collected and used for, and in connection with, these purposes and any other purpose described in our Privacy Policy.

 - e. insurance providers;
 - f. BML's car parking enforcement supplier and its agents (and if an enforcement notice is issued and the fee is unpaid, then to the supplier's nominated agency); and
 - g. any other organisation as expressly covered in our Privacy Policy.

It is possible that some of the information collected may be transferred to, and stored at, a destination outside of Australia, including but not limited to the United States of America and the Netherlands.
